- I. Call to Order: 6:03 pm
 - a. Introduction of Board Members

- II. Review of Meeting Minutes from 10/18/2021 Ryan made a motion to waive the reading of the minutes and vote to approve. Kyle seconded, and all in favor.
- III. President's Address Kyle Green Review of completed projects throughout the year.
- IV. Treasurer's Report Ryan Beasley
 - a. 2022 Budget

 - e. Pressure Washing Company delayed start date to beginning of January.
 - f. Mailbox Repairs Ryan introduced Corey Tappan from Mailbox Design vendor. Corey explained the four quoted options. BOD narrowed the four items down to two: Replace mailboxes, posts, and brackets for \$23,000 OR mailboxes only for \$8,000. Moving forward from either option, once the HOA replaces, the homeowner will be responsible for repairs to the mailboxes. Decision was made

by BOD to get a quote for repaving the neighborhood prior to making the decision on the mailboxes.
